- iii. They shall not indulge in any unlawful activity which is prejudicial to the maintenance of the public order and security of the State.
- iv. They shall ensure their presence before the concerned Police Station once in six months.
- v. The Police Station concerned shall keep watch on the activities of the released prisoners.
